# **Property Management**

Our community has been operating on a month-to-month arrangement with Trowbridge Company for over a year. Trowbridge Company has been our Property Manager since the beginning after the developer turned the rights over to the HOA. Our budgeting process will be starting soon so the Board has determined we need a formal contract for the new year. We have decided to issue a Request for Proposal (RFP) for Property Management Services to Trowbridge as well as others providing a similar service. The timing of an RFP will have it go out in the next 30 days. A timeline will be set at the next Board Meeting.

### **Mailboxes**

The Board has struggled to find a company to maintain and provide milling services for the wood panel sides on mailboxes. These mailboxes have been a wonderful symbol of our community for 25 years. Age though is taking its toll. We've sent out a questionnaire to all homeowners soliciting feedback on a possible replacement and the process to do so. Please respond to the survey by August 31.



### **Maintenance**

The Board is seeking quotes to repair the Boardwalk House roof in addition to replacing the fence around the waterway behind the lift station on Preservation Drive. We are in the process of collecting two quotes.

Other activities are reviewing options for replacing wood benches in the parks and reactivating the Float in the South Entrance Pond to keep it filled during drought times.
